The above figures speak for themselves. They speak of a slight growth in the People of God at the Cathedral, but they also speak of the need of another priest, I have made reference to this before! Ministry is the work of the whole People of God. Many people at St. Peter's Cathedral are aware of this and are

making wonderful contribution. However, much remains to be done. Charlottetown, Prince Edward Island and the whole world have not yet been won to Christ and His Kingdom. There is a vast amount of work yet awaiting able, dedicated workers, men and women who take their baptismal and confirmation vows seriously.

The physical conditions of our buildings have greatly improved, due largely to the efforts of our Property Warden and his committee. For the record, since my arrival as parish priest until the end of December 1987, we have spent and paid for, major repairs to the tune of \$225,000.00. Some of this was obtained from government grants, but most of it we paid for ourselves.


Our support of missionary work has been maintained, as the financial reports will show. Again this year we were able to help, in a small way, the two hard working parishes at either end of Prince Edward Island.

Archbishop Nutter conducted a most helpful teaching Mission in Passion Week 1987. We are most grateful to him. Perhaps we should tell him that when he decides to retire, we would be truly delighted to have him live with us on the Garden in the Gulf!

On the 1st of November Anglicans in Prince Edward Island voted to indicate their wishes for the Church in this civil Province. There was a clear call for change. The majority of Parishes voted for a Diocese of Prince Edward Island, but, by a very small majority there were more votes cast for side A than for side B. Where does that leave us? Bishop Peters has issued a Pastoral on the subject. Archbishop Nutter has written a letter to the Diocesan Church Society and to the Bishop of Nova Scotia on the matter. Both of those letters are printed at the end of our Annual Report.

We have an excellent Church School programme, with able and dedicated teachers. Why do we not have more children in our Church School? Christian education should be the concern of everyone at St. Peters. We have spoken about this on many occasions. Let us fill our Church School. God be with you all throughout 1988, whatever He has in store for us.

PROPERTY WARDEN'S REPORT

Father Westin, Vestry Members, and Parishioners of the Cathedral Church of Saint Peter, I have the honour of submitting the following Property Report for the year 1987.

Improvements and Repairs in 1987:

1. The interior of the Cathedral was redecorated.
2. The heating system was totally converted to hot water, and was connected to the District Heating project. This was financially assisted by a Federal Grant in excess of 50%.
3. New floors and redecoration were provided for the Cathedral washrooms.
4. New carpet was placed in the chancel of the Cathedral. This was financed by the Binney Group.
5. A new toilet was installed in the Rectory.
6. A new asphalt pad was placed at the Sacristy entrance.

Future Improvements and Repairs:

1. Repointing of the bricks of the Cathedral, 1988.
2. Exterior painting of the Rectory.
3. Touching up of the trim of 11 and 15 Rochford Square.
4. Reshingling of the Cathedral Roof.

In conclusion, I would like to thank the members of the Property Committee for their work during the past year, with special thanks to Stewart Benney, who spent many hours and expertise in planning and supervising the conversion of the heating system. I also wish to extend to the Binney Group grateful thanks for their generous donations to the organ fund. Our warmest thanks must also go to our sexton, Bruce MacKenzie, who organized and supervised the Cathedral redecoration. As well, we wish to thank Cyril Armstrong and Larry Arsenault, who ably assisted Bruce in this task, as well as all others who came and assisted when they could.

To both Bruce and June I extend my personal thanks for their tireless efforts in keeping the property beautiful and tidy.

TREASURY WARDEN'S REPORT

Father Westin, members of Vestry, and Parishoners of St. Peter's Cathedral, it was an honor to have served as your Treasury Warden during 1987, and I would like to submit the following report regarding the Parish finances for 1987.

Last year, 1987, was a busy year at St. Peter's. Financially we have lost some ground. Two major renovation jobs, the redecoration of the Cathedral and the renovation of our heating system were necessary, but expensive. The bottom line is that we have had to increase our loan and are further in debt than at the end of last year. We cannot continue to operate on debit budgeting and this fact must be kept in mind as we consider our budget for 1988.

At last year's Annual Meeting a motion was passed that the Vestry proceed toward engaging a Curate, if the Assistant Priest Fund could be capitalized to \$100,000 by June 1987. In view of other heavy financial commitments the Vestry did not feel we could launch a campaign to do that but instead set a target of \$40,000 for the year. I am pleased to report that during 1987 in excess of \$32,600 was received in donations. Total monies in the two funds, capital and income, is just short of \$85,000 as of the end of 1987 with \$73,000 in the capital account. With some special efforts in 1988 we should be able to bring the capital account to \$100,000.00, the minimum target set by Vestry before we undertake to engage a Curate. This issue will be discussed further, later this evening.

In 1987, our parishoners responded to the financial needs of the Parish as you seem to do every year. Our financial position did not change significantly during 1987 although we did have some major expenses. I trust that in 1988, with fewer capital expenses anticipated, we will be able to reduce our operating debt. However, the increase in the Diocesan allotment will create some additional financial burden - our response to this increase must be considered carefully. The Vestry believes that we have extended ourselves financially as far as we can in the allotment and it may be time for the Diocese to consider some budgetary restraints.

I would like to call to your attention that we did not have a stewardship campaign in the fall of 1987 but I hope that everyone will keep in mind the increase in our financial needs and will adjust their givings accordingly.

I would also remind all parishoners of the existence of our trust funds and commend them to you. Donations to the Memorial Fund or the Assistant Priest Fund will be welcomed. Please consider these funds for memorials or as a bequest.

Practically everyone in the Parish participates in the major fund raising functions at St. Peters. The Annual Bazaar and Dinner is an excellent example and the Binney Group deserve much credit for organizing this major Parish function. There are many individuals in the Parish who deserve credit but I will only recognize several. Eddie Acorn as Vestry Clerk, and Fred Weatherby as Treasurer deserve our thanks for their efforts. I would also thank the members of the Finance Committee who have assisted me through the year. To everyone who has contributed to the financial well being of the Parish I would like to express my sincere thanks.





REPORT OF THE CATHEDRAL CHOIRS


Father Westin, Vestry Members and Parishioners of St. Peter's Cathedral,

Dear Father Westin:

Enclosed is some data on your Bureau's operations up to date, particularly its financial position. Board members' attendance at monthly meetings is also a matter of concern.

This Bureau was set up originally by the major Protestant churches of this area who were solely responsible for its total budget. It is governed principally by Board members appointed by these churches. In more recent years the United Way's contribution comprises the major portion of the budget, yet our churches are still responsible, through their Board members, for its overall operations, support and deficit.

Of late many Board members are not supporting the Bureau by their regular attendance at Board meetings to the extent that the opening of meetings often has been delayed because of lack of a quorum. This letter is an appeal to take note and help this situation and help revitalize the members' interest in the responsibility of running your Bureau. You will note, too, the churches' contribution to date in some cases has ceased and is greatly in arrears of the overall objective of \$19,475 for this year. We cannot carry on successfully if a feeling of abandonment by our churches prevails or if the churches' appointees fail to attend and participate in the monthly meetings.

Herewith we also enclose:

1. Estimated receipts and expenditures for 1987 and updated 1988 budget
2. A statement of the churches' 1987 contributions to date, combined with proposed 1988 church allocations.

It is noted that two churches on the statement have made no contributions for several years. Hence they are not included in 1988 allocations; nevertheless their contributions would be most welcomed. The 1988 budget allocation increase from \$19,475 to \$20,225 is approximately 3.85% or just under 7% when you assume the share of the churches not participating.

Prince Edward Island District

On December 13th, 1837 the Prince Edward Island Auxiliary of the British and Foreign Bible Society was established at Charlottetown under the patronage of the Lieutenant Governor, Sir Charles A. Fitzroy. On February 18th, 1987 the 150th Anniversary of this occasion was celebrated at the Annual Meeting of the Prince Edward Island District of the Canadian Bible Society with the present Lieutenant Governor, the Honourable Lloyd MacPhail and Mrs. MacPhail, the Premier the Honourable Joseph A. Ghiz and Mrs. Ghiz and many other distinguished guests in attendance.

The meeting was presided over by the President, Mrs. Doreen McInnis who was succeeded as President in the latter part of the meeting by the Reverend Douglas R. Woods.

You may remember that in 1986 our long time District Secretary Mr. Boyd Butt returned to a parish ministry and the Reverend Byron F. Howlett came out of retirement to replace him while a successor was found. On June 1st the Reverend Delbert G. Barnister, who resides with his wife and family in Sussex, New Brunswick, became the new District Secretary.

Also on June 1st the bible house building at 131-135 Kent Street was sold to Daniel Tweel Sr. for \$212,766.00 which after paying a commission of 6 per cent. gave the Canadian Bible Society \$200,000.00. Your delegate Mr. Reagh was actively involved in the negotiations and ultimate sale of this land and building. The store contents, except bibles and scriptures, were then sold to the public and the Maritime Christian Book store giving the Society another \$14,000.00.


As you may know most of the stores in Canada of the Canadian Bible Society have sold off their stock and are now bible and scripture outlets. For some reason the sales of Bibles, New Testaments and Scriptures are up this year in our store which is now located in the former Royalty Mall, now known as Oak Tree Place, which was officially opened with much ceremony this year on Monday, September 14th.

Except for a \$20,000.00 legacy given this year to the Society the income figures in the financial statement including money from the Song-a-Ramas, the store, all donations collected locally and the direct mailing gifts will this year be very similar to those in the statement of 1986. In 1987 we should again be well ahead of our sister provinces in collected monies and still leading the world in per capita giving.

In some areas such as Kensington, there was no personal canvass and the contributions are down approximately \$3000.00. The need now in the Charlottetown Branch is to find more people for door to door canvassing and to find 3 executive members for the Charlottetown branch.

Your delegates feel that after more than 10 years of service they should not reoffer for these positions. They have given technical help when such skills were required particularly the last two years. Now there is no property to manage and the delegates you send this year should have the ability to inspire people within our church to offer their services as canvassers to enable the important distribution of Bibles and Scriptures and their translation within Canada and the world to continue and expand that the Word may be heard by all.

## SIGN OF THE FISH

Final Report

In February, 1987 the Sign of the Fish celebrated its 15th anniversary with an evening worship service of celebration and thanksgiving, and a social sharing. We gave thanks for the work of the volunteers over the years and prayed for the guidance of the Holy Spirit to lead us in the days ahead.

The organization has continued to receive office space, light, heat, advertising and printing at no cost. The churches have provided bulletin space and rooms for meetings. We acknowledge especially the support of both St. Peter's Cathedral and the Kirk of Saint James for their strong support and encouragement through the years. We pay tribute to the Alpha Y's Men's Club and the Charlottetown Lions Club for their generous donations. To each we offer a special word of appreciation and deep gratitude for their support.

Over the last several months the executive met, facing an increasing concern for the future of the Sign of the Fish. The loss of present volunteers, the inability to recruit replacements and the birth of 46 new agencies since FISH began led to a decision to call a general meeting of all volunteers to discuss the future of the organization. Sadly and reluctantly it was agreed to cease operation at the end of 1987.

Seventeen years ago several dedicated people from Saint Peters and Saint James, recognizing a need in the community for a help line, launched a service which later became ecumenical and has reached out far and wide. They had a vision of the need and set out to fulfill that need with a highly efficient and compassionate service. The Sign of the Fish has helped numerous people and has been instrumental in saving lives, in relieving anxiety, in offering friendship to the lonely and information and referral to those in need.

A great sense of loss is felt by every one involved in the movement. However, we should rejoice and give thanks for the wonderful work that has been achieved. There is no doubt that FISH has served as a catalyst to motivate some of the other helping agencies. All members of the Sign of the Fish have given their time and energy, seeking neither recognition nor reward, but the reward is truly in serving the Master for he said, "Inasmuch as ye have done it unto the least of these my brethern, ye have done it unto Me".

Over the years we have been greatly indebted to the members of the executive and to all those who served on committees (Office, Recruitment and Training, Resource Files and Publicity).

We say, "Thank you" and may God bless you in whatever endeavors you may embark upon in His service. Your loyalty and devotion will never be forgotten.

The following is a copy of a letter from the Most Reverend H. L. Nutter, sent to the Chairman and the 2nd Vice-Chairman of the D.C.S.:

" I write to both of you in your capacity as Diocesan Bishop and as Archdeacon in Prince Edward Island and Chairman of the Diocesan Church Society of Prince Edward Island.

I am grateful for the information which has been passed on to me by Archdeacon Power relative to the plebiscite vote on November 1 regarding the status of the Church on Prince Edward Island. I find that the information that has been given has been full and complete, and in my capacity as Metropolitan, I will, at the right time, pass this on to the Provincial Synod of the Province of Canada.

While interpretation of a vote such as this can lead in several directions, my feeling on the balloting is as follows: while there was a small overall majority of votes cast in favour of retaining links with the Diocese of Nova Scotia, the one overriding fact that comes across to me is that there is a feeling within the Church in Prince Edward Island that they wish to negotiate with the Diocese of Nova Scotia some sort of changed relationship. This may be described by the term 'special status' which I believe was used in the Hilchey-Stevenson Report.

I detect that there is a desire on the part of the people in the Church in Prince Edward Island to do everything possible to make the Church there even more effective than it has been, and to use every method possible for strengthening its witness. With none of this can I be in any disagreement, but rather I think there are very hopeful signs in this kind of conclusion, both for the Church on Prince Edward Island and in regard to its relationship with the Diocese of Nova Scotia.

I would now suggest (and in doing this I do not have any authority to do so beyond the fact that the original petition for study was submitted to the Metropolitan) that the Diocesan Church Society and the Diocese of Nova Scotia begin consultation outlining guidelines for the special status which the Church in P.E.I. is seeking while still remaining an integral part of the Diocese of Nova Scotia. This could be done presumably by the establishment of a joint task force representing the Diocesan Church Society and the Diocesan Council of the Diocese of Nova Scotia. I believe that such a task force, if it were established, should be given terms of reference and time limitations. What the terms of reference might be, I cannot say, except that it would appear to me that they should be given authority to make suggestions to the Diocesan Bishop and through him to the proper Synodical authorities regarding the relationship of the Church on P.E.I. with the Church in the remainder of the Diocese of Nova Scotia. There should be specific suggestions on finances, personnel, etc., if those are matters that are of concern to the Church on Prince Edward Island. In addition to that, I believe there are certainly background requests for representation of the Church on Prince Edward Island on Diocesan, Provincial, and General Synod bodies. Whether this can be done constitutionally, I am not certain, but they should be considered.

It appears to me that Provincial Synod would not act on any matter relative to the relationship between the Church in Nova Scotia and in Prince Edward Island, unless there were representations made to it as a result of the suggested negotiation. Therefore, I would hope that anything that might need to come before Provincial Synod could be finalized by June of 1988, since Provincial Synod will meet in October of that year.

There was one matter raised in the Hilchey/Stevenson Report which raises some questions that could be faced by Provincial Synod, but I believe that it should only be done on the recommendation of the joint task force or whatever instrument is used for negotiation. This is the question of the present status of the Church in Prince Edward Island. I understand that there is a difference of opinion between the members of the Hilchey/Stevenson Commission and the Diocesan authorities on the interpretation of this. However, it raises the question as to whether the Diocese or the Church on Prince Edward Island through the Diocesan Church Society, or those two bodies jointly, should petition Provincial Synod to clarify whether Prince Edward Island is an integral part of the Diocese of Nova Scotia or not. If that is to be done, then my understanding is that it would then need to go also to General Synod in 1989 for ratification. However, if there is agreement between the two bodies that the Diocese of Nova Scotia does now and always has included Prince Edward Island, I see no need for action through Provincial Synod on this. But, if there is doubt about it, you may wish to petition Provincial Synod for a determination of status one way or the other.

I hope that this is of some help, and if there is anything further that I can do, please do not hesitate to be in touch with me.

With best wishes to all concerned, and with the assurance that I believe there are many hopeful things coming out of this whole situation which need to be pursued for the good of the Church both on Prince Edward Island and in the whole Atlantic area, I am

## PASTORAL LETTER TO ANGLICANS ON PRINCE EDWARD ISLAND

Dear Friends:

The results of the November 1st voting have registered that the majority of those who cast ballots favoured the option to be part of the Diocese of Nova Scotia, but with special status within that relationship.

Whenever an issue is eagerly pursued and passionately contested, then deep-felt disappointments result when the outcome is not as one anticipated. In the Christian Community, we are called to exercise a forgiving acceptance towards one another. One of the challenges now before our Church on the Island is the call to be Christ-like in our forgiveness and acceptance of one another.

I believe it is now necessary for Island Anglicans representing all opinions on this issue to come together as a single family within the wider fellowship of the Diocesan Family. It is time to stop debating the questions of history and to move forward together with the work of Christ in this age. We have given due consideration to the Hilchey-Stevenson Report, the voting has taken place, now we must close that chapter.

To that end, I am setting in place a Task Force consisting of representatives from the D.C.S. Council and the Diocesan Council. The mandate of that Task Force is to give consideration to what special arrangements and institutions might assist in making the work of the Church throughout our Diocese more effective, with particular reference to P.E.I. The Task Force is to report to me on a regular basis.

Let us move together as one Diocesan Family into the challenging frontiers which are before us, striving to fulfil the ministry and mission of the One who has called us to be His people.
