**ANNUAL MEETING ST. PETER'S CATHEDRAL,
JANUARY 30th, 1994**

Father Harris opened the meeting following prayers, and remembering the faithful departed since our last Annual Meeting, namely:

Motion: *The minutes of the last Annual Meeting were approved. Moved by Nancy Warren, seconded by Charles MacKeen. Carried.*

A vote of thanks was extended to the Ladies for a delicious supper. Thanks also to all the parishioners who contributed food for our supper.

REPORTS:

Rector: Fr. Harris spoke on his report which is printed in the Annual Report Book. He thanked the various Committees, Groups, etc. for their assistance during the past year.

Motion: *Dr. Winter moved the adoption of the Rector's Report as printed in the Annual Report Book, seconded by Dr. Edgar MacDonald. Carried.*

Mr. Cyril Armstrong asked if there was anything to report on an Assistant Priest for the summer months. Fr. Harris said nothing has been decided on whether we will have an Assistant Priest or a summer student to assist in the parish as has been the case in the past few years.

Property Warden's Report: Stewart Bennie, Property Warden, reported that we **MUST HAVE** a new roof on the west side of the Cathedral. He said that it is in bad shape, and if nothing is done this coming year we can expect to see the roof leaking. He went on to explain the other work done to date. He also thanked Bruce and June MacKenzie for all the extra work they have carried out during the year. The extra work included things not normally expected of a Sexton or his wife.

Trust Accounts: Rory Francis moved the adoption of the Trust Accounts; seconded by Brenda Large. *Carried.*

Assistant Priest Fund: Rory reported that we have \$55,172.00 in Accumulated Interest in the Assistant Priest Fund.

Motion: On behalf of the Vestry, Rory Francis moved a motion, seconded by Mrs. Holland, that we put this interest income into the Capital Fund Account.

Amendment to the Motion: Mr. MacKeen moved that all accumulated interest in the Assistant Priest Fund account be placed into the Capital Fund until such time as we obtain an Assistant Priest. *Carried.*

Budget: Rory Francis presented the proposed Budget for the coming year. After a discussion the budget for 1994 was approved on a motion by Rory; seconded by Dr. MacDonald. *Carried.*

Thanks: Rory extended his thanks to all involved with the Financial Operation of the Cathedral.

ACW Binney Group: Moved by Pat Rogers, seconded by Nancy Warren. *Carried.*

Binney Treasurer's Report: moved by Betty MacKeen, seconded by Paula Connolly. *Carried.*

Inglis Group Report: President's, Secretary's and Treasurer's Reports moved by Brenda Large; Seconded by Edgar MacDonald. *Carried.*

Cathedral Men's Association: Moved by Cyril Armstrong; seconded by Dr. Karl Winter. *Carried.*

Cathedral Men's Association Financial Report: Moved by Cyril, seconded by Dr. Karl Winter. *Carried.*

Altar Guild Report: moved by Dorothy Orton, seconded by Betty Acorn. *Carried.*

Fr. Harris said that he was most grateful to the Altar Guild for their untiring work. He said the Vestments, etc. are always needing cleaning, repairs, etc. and members of the Altar Guild perform these tasks faithfully throughout the year.

RECTOR'S REPORT FOR 1994

Dear Friends, and members of St. Peter's Cathedral Family:

Our 125th Anniversary Year, 1994, has come and gone, and what a special and memorable year it was! It was a year which, I trust, will long be remembered. Highlights of the year included the following: The Rev'd George Hodgson Sunday on March 6, when the Holy Eucharist was celebrated as it might have been in Fr. Hodgson's time; the Anniversary Year Hymn-Sing on Sunday, April 24; the Ascension Day Latin High Mass on May 12; the Anniversary Year Service itself on Sunday, June 12, with Archbishop Nutter as Guest Preacher; the Patronal Festival High Mass on June 29 with Bishop Anthony Burton as celebrant and preacher; the Rev'd Canon James Simpson Sunday on July 24 including the dedication of All Souls' Chapel as a National Historic Site that afternoon; the Rev'd Canon E.M. Malone Sunday on Oct. 30; the Parish Mission with Archbishop Nutter Nov. 6-9; and the Annual High Tea in a Victorian style on Nov. 23. In addition, two former Rectors were invited to preach at the 11 o'clock service, the Rev'd Canon Gerald Moffatt on Sunday, Sept. 25, and the Rev'd Canon H.M.D. Westin twice, on Sunday, July 3 and on Sunday, Dec. 4.

I want to thank all those who worked so hard to make the Anniversary Year a success - especially Ron Orton for chairing both the Anniversary Year Committee and the committee that planned the parish mission, and Brenda Large for serving as Co-ordinator of special events. My thanks to all the members of the Anniversary Year Committee, and to Dr. Reesor and the choir for the extra time they took to prepare special music.

There are so many dedicated people who do so much for the life and work of this parish, and support me in my work as your parish priest. Besides thanking Dr. Reesor and the choir, I also want to express my thanks to the sacristan and servers, to the ladies of the Altar Guild, the Binney Group & the Inglis Group, to those who assist me with the Youth Group, and to those who serve on Vestry, especially the two Parish Wardens. I express thanks to Rory Francis, Janet Doiron and all Sunday School teachers for their dedicated service. My thanks also to our Sexton, Bruce Mackenzie, and to Office Secretary, Heather LePage. A special word of thanks to Peggy Holland and all the members of the Cathedral Monthly Committee, and to Connie Macmillan and all the Cathedral Couriers. Father Jacques Smith our Honorary Assistant, Canon Tuck, Father Westin, and my father Canon Walter Harris all who assist me in a variety of ways. I am most grateful to them. We are fortunate to have so many retired priests active in the life of our parish.

Each year in my report, I say a brief word about the financial situation of the parish. I am proud of our members for responding generously in difficult economic times. Counting the donations given towards the roof repairs, our members gave more in 1994 than in 1993. However, we were still below the budgeted amount hoped for in our total receipts, and the on-going (and ever increasing) accumulated deficit of the parish continues to be a concern. This situation should be given serious consideration in the near future.

Confirmation. Bishop James Allan (Assistant Bishop) visited St. Peter's Cathedral in early May and confirmed four adults: Michael Donovan, Frank Reid, Judy Reid, and Lily Anschutz. Then on Sunday, Oct.

16, we welcomed our Bishop, the Rt. Rev'd. Arthur Peters, for the Sacrament of Holy Confirmation. Eight young people were confirmed (James Arsenault, Matthew Chandler, Graeme Francis, Vicki MacEachern, Catherine Nicholson, Andrew Richardson, Lindsay West, and Timothy Woodside). This occasion also marked Bishop Peters' official visit with us for our Anniversary Year.

Summer Assistant. We were fortunate to have a student working as an assistant to the rector, for the four summer months of 1994. Craig O'Brien, a graduate of King's College, Halifax, whose home is in Fredericton, assisted with the many Sunday and week-day services, worked with the Youth Group and other parish organizations, visited in Nursing Homes, and visited approximately 100 homes in the parish. I recommend that, if possible, we continue to have a summer student. It is a great help to me and to the parish, and is, I trust, a beneficial learning experience for the student involved.

Assistant Priest. The time is drawing nearer when we may be able to have an assistant priest. The figures in the financial reports show the total we now have in this fund and the amount of interest that accrued in 1994 (see p. 18). I thank parishioners for their continued generous donations to the Assistant Priest Fund, and encourage them to continue to support this fund.

Theological Conference. Parishioners are asked to note that we will be hosting the annual Atlantic Theological Conference in 1995. It is not our turn to do so, but for various reasons the Conference could not be held in Halifax this year, so St. Peter's Cathedral is happy to have the Conference take place here. (Topic: "The Idea of the Church in Historical Development"). The dates are June 26-29. The Conference will therefore coincide with, and be a part of, the observance of our Patronal Festival.

Conclusion. These are difficult and challenging times for the Christian Church and for the part of it to which we belong. May St. Peter's Cathedral continue to be faithful to those Christian and Catholic principles on which the parish was founded 126 years ago, and may God bless us as we seek to discern his will — in the words of the Collect for the First Sunday after Epiphany "that we may both perceive and know what things we ought to do, and also may have grace and power faithfully to fulfil the same, through Jesus Christ our Lord. Amen."

May God's blessing be upon us throughout the year 1995.

PROPERTY WARDEN'S REPORT

1994

The Property Warden's Report, when dealing with a 125 year old property, is usually a recitation of the many things that need to be done and the lack of money to do them. In this respect 1994 was no different from previous years, however it was different in how the major project for the year was carried out. The west side of the church roof was in very poor condition (leaking) and needed replacement. Rod Inness created a fund raising idea to finance the roof's replacement and the church members supported the resulting project enthusiastically. As a result over \$8,600 was raised and the west side of the church roof was replaced. An unexpected result of the project was that \$3,100 was left over, to be used when the east side of the roof is replaced.

Water problems in the church basement (Church school area) have been a long standing problem. Bruce MacKenzie installed a third sump pump in one of the class rooms along with other works to direct water to the sump. While it may be too early to claim the water problem solved it appears to have improved the situation significantly.

Renovations to one of the rectory bathrooms was completed with the installation of new cabinetwork, sink taps and flooring. The remaining flower gardens at the rectory were re-planted.

As a result of the tight money situation (the roof being an exception) most projects are being carried out by our sexton with help from Rod Inness on occasion.

In 1995 work will have to be done on the rectory garage before further frost damage occurs. It is hoped that the north wall of the Hall will be repainted this summer.

While the maintenance work on the church properties will be somewhat restricted due to financial conditions there are some serious problems facing us in the future i.e. brickwork on the church east wall needs attention, various sections of the brickwork on the tower require repointing, the church driveway is in need of re-paving and the east side of the church roof will have to be replaced in a year or two.

The most consistent feature of these reports has been the support and diligence of our Sexton, Bruce MacKenzie and his wife, June in keeping the church and the surrounding property looking attractive. The second and equally important feature has been the financial support received from the Women's groups. A third feature has been Rod Inness and his skills which have been a tremendous asset to St. Peter's.

TREASURY WARDEN'S REPORT

On behalf of the Vestry of St. Peter's Cathedral, I am pleased to present the statements of revenue, expenditures and trust accounts for 1994, along with the proposed budget for 1995.

Envelope givings dropped slightly in 1994, although some late receipts (early in 1995) would suggest that there is very little change. Another very positive note is the receipt of \$8700 in donations to our Building Fund for the Cathedral Roof project, so that overall our parishioners' provided excellent support in 1994, in a year when many organizations' saw large reductions in charitable donations.

Revenue was approximately \$23,000 less than budgeted for two reasons. Our envelope givings, while stable with 1993, were below the budget target by \$16,000. Secondly, we set aside at year end an Organ Reserve of \$7500 which was an unspent Budget item in 1994, and a Roof Reserve of \$3100 which represents the roof project donations which were not needed in 1994 and will be held until further roof maintenance is required. Our expenditures were also less than budgeted, primarily in Cathedral maintenance, organ expenditures, and our Allotment to Synod which was in arrears at year end by \$11,600. Overall our 1994 deficit was \$7500, resulting in an accumulated cash deficit of \$36,000 and Allotment arrears of \$24,000 (page 22).

The Trust Fund Account Statement is printed on page 18. Trust Fund Income of \$10,100 was transferred to Current Account in 1994. Donations to the Assistant Priest Fund were \$10,143 in 1994. Previously accumulated income from the Assistant Priest Fund of \$55,172 was capitalized in 1994 and \$20,900 in additional income was received bringing the total assets in the Assistant Priest Fund at year end to \$270,941.


The proposed budget for 1995 includes envelope givings of \$150,000 and a deficit for the year of \$4,500. The Organ Reserve will be used for major organ improvements in 1995. Allotment of \$28,100 is budgeted to be paid in full. It is not positive to forecast another deficit in 1995 and obviously an increase in givings above budget would be welcome. And extra \$1 per week from each of our current givers would raise over \$9000!

I would like to thank our Cathedral Finance Committee — Paul Kays, Peggy Holland, Brooke Brady, and Eddie Acorn for their counsel this year. 

REPORT OF THE CATHEDRAL CHOIRS

Father Harris, members of the Vestry, and Parishioners of St. Peter's Cathedral, the following is the report of the Cathedral Choirs for 1994.

During 1994 the Cathedral Senior Choir maintained a membership of 26. The Junior Choir started off the year with 11 members, dropped off to 8 early in the fall, but ended the year with 10 members. The Choirs attended 40 Wednesday evening rehearsals and 6 extra rehearsals for special services. In addition, the choirs sang for 52 Sunday morning Masses, 19 extra Feast Day, Holy Week and Evening Services, 2 Weddings, 2 Burial Office, and 2 Requiems. Members of the Choir also provided music for the Pageant for the annual Parish Christmas Concert, and several members participated in the Hymn Festival sponsored by the Royal Canadian College of Organists in October.

Ascension Day was, once again, gloriously celebrated, with our 3rd Annual Latin Mass, during which the Senior Choir performed Haydn's "Mass of St. John of God" and Cazzatti's "Laudate Domino" with orchestra.

In observance of the Cathedral's 125th anniversary year, the Choirs prepared considerable new music, with emphasis on compositions of former parishioners and on the type of music which would have been sung in the parish in years past, of most particular note being the re-introduction of the "Missa de Angelis" which was in regular use during Canon Malone's incumbency.

Expansion of the organ continues, with 1995 earmarked for significant restoration to the console. This will be a very expensive process, and although we hope to cover part of the expenses through grants, there will be some cost to the parish. Donations to the Organ Fund towards this restoration of the console would be gratefully received, and would make excellent memorials. If interested, please speak with Fr. Harris or me.

I would like to take this opportunity to express my most sincere thanks to the members of both choirs for their loyalty to the Church, to music, and to me. The Cathedral's choristers are very supportive people, committed to offering the best that they can to our worship, and it is a privilege to work with them. In addition, I wish to thank Father Harris and all those parishioners who have encouraged us so much, and who have helped to make St. Peter's musical tradition so fine.

Special thanks is due to our assistant organists, Susan Stensch and Gloria Jay, for their help in playing the 9:30 Sunday morning services, the Stations of the Cross and extra weekday Masses during Lent, the Ecumenical Noon-time Services sponsored by the Charlottetown Christian Council during Holy Week, and the choral services while I was on vacation.

I would also like to acknowledge, with gratitude, the special financial support shown the Choir and the Organ Fund by the Binney Group and individual members of the Parish.



St. Peter's Cathedral Monthly

The Cathedral's 125th Anniversary Year was the 35th year of publication of *The Cathedral Monthly*. Canon Malone began the newsletter in 1922; it retired with him in 1952. Its second life, with Canon Malone's original masthead and Personal and Parochial column, began in 1990.

The Cathedral Monthly was published 10 times in 1994. In previous years there had been a combined September/October issue; in 1994 the Summer issue was omitted and a September one produced instead. The average printing remained at 425 copies per issue. These were for parishioners, post-secondary students, paid subscriptions, Cathedral and Diocesan Archives, office, files, and a few for Father Harris to give to visitors and prospective parishioners. Complimentary copies are mailed to former Rectors and we are told that this is very much appreciated.

The cost of printing increased dramatically this year, the first major increase since late 1990. Fortunately, gifts and the direct financial support of parishioners helped to reduce the impact of this on the Church's financial position. This year, for the first time, receipts (donations) and expenditures of *The Cathedral Monthly* are shown as separate items in the parish financial statement.

Two very large gifts received were a bequest of \$500 from the Estate of Frank Sumner Orford and the donation of a Transcription Machine from Paula Connolly. An anonymous donor provided \$47 for graphics material and the Binney Group gave \$100 for a printer cartridge. We are grateful to parishioners who used the blue church envelope to contribute directly \$434 toward the cost of publishing the newsletter.

When all goes well, *The Cathedral Monthly* is in the mail boxes in the Cathedral porch on the second last Sunday of the month (with the exception of the Christmas and Easter issues). On the last Sunday of the month, the Cathedral Couriers deliver with the mail any copies which have not been picked up by parishioners or members of their families. Because mailing costs are so high, it would otherwise be impossible to reach every parishioner 10 times per year. The help of Connie Macmillan and the Couriers is invaluable.

Subscriptions at \$13.00 per year run to December 31 but may begin at any time calculated at the rate of \$1.25 per month. These rates generally cover mailing costs only but, after three and a half years, we were happy to find a surplus had accumulated just large enough to finance a cover, printed in colour, for the 125th Anniversary Year issue of June 1994.

Twenty subscribers have renewed for 1995, sending the newsletter to family, friends, and godchildren living in different parts of the world. We have learned directly from several that they enjoy receiving it, and on at least two occasions of which we are aware, other publications have reprinted *Cathedral Monthly* articles.

We continue to look for writers among our parish family who will tell us about articles that they would be comfortable writing, and we value ideas from parishioners on subjects they wish to see covered in the newsletter. Please continue to give us items for The Personal and Parochial column so that important events in the life of parish families will not be missed. (Tips are always verified; sources are confidential!)

Thank you to Father Harris for his patience and his generous time commitment to the newsletter, to Island Offset Inc., and to all who helped and offered encouragement. On the back page of each issue you will find the names of those who contributed in a tangible way, making it a pleasure to produce that issue for you.


We continue a policy of fiscal restraint so that the endowment fund continues to build and will provide future funds for future projects for the cemetery.





REPORT OF THE CAMP KINGSTON COMMITTEE, 1994

The Committee met about three times during the year. Camp Kingston and the Camping Program were the main topic of several Diocesan Church Society Council meetings throughout the year. The summary of discussions, and decisions made, was the result of DCS meetings.

JANUARY 1994

A motion to reopen Camp Kingston for operation in the summer of 1994 was defeated. A motion that the present Camp Committee be directed to organize a Camp, at some location, for Anglican camp for this year (facility on P.E.I.) was carried. The Camp Committee began investigating the possibility of renting a camping facility for the 1994 season.

ANNUAL MEETING, APRIL 1994

Father Harris reviewed the events of the past year, describing the problems encountered by the various inspectors (Health, Fire, and others). A handout, outlining several possible ways of dealing with Camp Kingston, was circulated.

After considerable discussion, a show of hands indicated that:

- a. 6 — bring the Camp up to safe standards and further develop it;
- b. 1 — demolish the Camp and rebuild on the same site.
- c. 2 — sell the Camp, buy another one;
- d. 31 — sell property, buy another, but not do anything with it for now.
- e. 31 — dispose of Camp Kingston and rent another Camp.

It was moved and seconded that the choices "d" and "e" be referred to the DCS Council for consideration and expedition.

Decision To sell the Camp Kingston property. The Camping Program will continue — at a rented facility.

SEPTEMBER 1994

REPORT OF REGISTRAR/GENERAL ASSISTANT

Twenty-four children attended the Camp, August 22 to 27, 1994, at the rented camp facility, Camp Keir.

We had the Camp Keir staff Cook and Waterfront Director for the week. Among the Counsellors were two girls who were Camp Keir campers and a male teen who also had been a Camp Keir camper. In addition, we had two Anglican teenage "Junior Counsellors".

The only missing ingredient to an otherwise super Camp week was participation and support of the Clergy. Two priests visited for a few hours each: one on Wednesday and one on Friday. In addition, another visited for a short while on Friday. Probably the children preferred sports and swimming (maybe even "crafts"), but this is a Church Camp ...

Rev'd. Lori Ramsey has agreed to attend Camp next year. I would like to see two or three priests make a commitment — that way, if something unforeseen happened, there would be back-up Clergy.

REPORT OF THE CAMP KINGSTON COMMITTEE, 1994, cont'd.

On a positive note, all parents I spoke to tell me their child is pleased with the Camp and wants to come back in 1995.

For the most part, the Camp ran smoothly. The direction of Greg Shepherd was excellent. Now that we know what the facility is like, the preparation for another year will likely be easier.

The Cook and Waterfront Director, when asked their opinion, agreed that the children were happy, the staff got along well; more organization and more extensive Chapel services could be beneficial.

1994 Annual Report

The Charlottetown Christian Council meets once per month at St. Peter's Cathedral. Preceding the dinner and meeting is a service of worship in All Souls' Chapel.

The Council meets to discuss many topics of interest and concern to the community. The main topics of interest this year were as follows:

The Triennial Assembly of the Canadian Council of Churches was held in Charlottetown, May 14-18, 1994, and was well attended by delegates from across the country.

The shelter for the homeless and/or halfway house reported that the financial status is fair at the moment, but further monetary support is required to continue its operation. An appeal is being made to area churches to begin fund raising efforts to ease the financial burden on the shelter.

In respect of the Chaplaincy programme at the Queen Elizabeth Hospital, a coordinator has been appointed to fill the vacancy left by retired clergy.

A conflict arose at the Sleepy Hollow Correctional Institution in relation to the scheduling of noisy recreational activities in the gym at the same time as worship services were being held in the chapel, next door. A letter to the Superintendent at the jail solved the problem to everyone's satisfaction.

As usual, the year ended with a Christmas service and party at Sleepy Hollow Correctional Centre, at which Fr. Smith was presented with a special and much deserved gift in honour of his dedicated years of service as Chaplain at Sleepy Hollow.

SLEEPY HOLLOW CHAPLAINCY REPORT

Locked up — Rejected by society — Make life worth living

The prison ministry system in our country is a magnified reflection on the moral decay in our society. Priorities that prisons have: 90% of the budget goes to the physical lock-up, housing and feeding of the prisoner; 10% or less goes to rehabilitation. No programming money goes to spiritual development. They are not overly enthusiastic about the spiritual aspects of the life transformation process.

In the history of the world, there will have to be an end to crime. Motivation is the way to freedom, the road to change is by no means an easy one; my advice for each of you is to look inside yourself ... and stop lying to yourself!

A young man, came to the chapel with a personal problem. He was completely dejected and depressed; tormented by an exasperating frustration. "Why did I do it?" he kept asking, as though unable to believe he could have been so stupid. "What is wrong with me? I had the opportunity of a lifetime, and I blew it...."

This young man was so beside himself, that he excited my deepest sympathy. I gave him the following suggestions on how he might learn to handle mistakes in the future. Learn from your mistakes — positive action. A mistake is not something to complain about or to be ashamed of, it is a great teacher. Mistakes are an issue in life that all of us must understand and deal with.

A young man in prison is realizing the impact of loneliness for the first time since he has been separated from his family and friends. If he has never had any Christian training he will assume that God and church are for others, not for him. If he did have some religious training in his childhood he now feels that God has let him down. He does not understand the Good News of the Gospel. If he is a Christian, he may need the reassurance of the security of the Believer, the personal value that he has as a child of God. The non-Christian inmate needs to know that God loves him, that Jesus Christ died for him.

Rehabilitation The Christian knows that there is no one beyond the power of the divine grace. We can never regard anyone as hopeless, or beyond the hope of reform. Christ seeks always to bring us to repentance and new life. It is easy to blame environment and heredity but there is only hope for a person when we treat them as responsible, acknowledging that Christ is the centre of our life and not self. I said to my friends God cares and wants to help you and you need God's help. Many prisoners feel unworthy and undeserving of God's attention. True freedom is not getting out of prison. It's freedom from guilt, from fear and anxiety.

Often I have asked myself what it is which best indicates that a person in prison has grown and developed through his incarceration and have concluded that it is the capacity to be thankful and the ability to get out of one's self and be concerned for other people.

Again and again our government agencies have received large appropriations of money to launch campaigns to reduce crime ... The results have been mostly failures; the reaction is a demand for more prisons, longer sentences; more police officers; and of course, more taxes.

Why not try a better approach??? Every church should include prison ministry and support because the jails and prisons in this province are among its most neglected mission field. The church should minister to the families of the inmates. They haven't committed any crimes, yet our society has a tendency to reject them as if they had. The church can and should help.

The chaplain is available to assist parishes in developing their awareness of possible church responses to crime.
